Hope you are well

I am reaching out to you both to ask if you would be able to assist in any way in respects to the below on-going discussions with National Highways on the diversion route our Agents, the South Wales Trunk Road Agent are looking to utilise to undertake the forthcoming resurfacing of the M48 Eastbound carriageway.

As you know, due to the current condition of the M48 Eastbound carriageway it is crucial that we undertake resurfacing works prior to the commencement of your Prince of Wales (POW) bridge refurbishment contract to provide resilience to both Welsh Government and your network during your forth coming POW. I know through the POW works you are looking to encourage the use of the M48 which makes it all the more critical that we are able to undertake our works and as I am sure you will agreed it will be of collective benefit to both Welsh Government and National Highways and it is in all our interests to ensure these works do take place.

As you will see National Highways also have some works planned at the same time on the M5 between J14 and J17 which will result in two diversion route signing at the same time but we consider, whilst not ideal, can be accommodated. Discussions with the South Wales Networks Occupancy teams reveal that no issues are anticipated in relation to the very short section of South Gloucestershire network that would need to be utilised and discussions are taking place in this respect.

Unfortunately if we were to wait until the M5 J14 to J17 works were completed on 3rd June that would leave us insufficient time to complete the works prior to your POW works commencing.

Contracts are currently out to tender for the resurfacing works which indicated works commencement of 13th May 2024 and all works to be completed by the end of June 2024. As soon as a programme is available from the successful contractor we can share that information with you.

I would be grateful for any assistance and support you could provide.

My apologies for the delay in getting back to you.

Please can you confirm whether you intend to work every night for 5 weeks, including weekends?
Is your end date currently the morning of 10th June? I've started booking this under NEM 372903.

I'm not personally aware of a closure on the M4 POW bridge starting on the 8th July. [REDACTED] & [REDACTED], please could you let us know whether this will be the case?

I know that we have planned closures of the M4 POW bridge EB on the 13th & 14th May. And closures of the M48 WB Severn Bridge on the 5th June. Which would clearly be an issue for SWTRA's diversion route [REDACTED] presumably you had already sought SWTRA's approval for the diversion onto their part of the network on these dates?

From our perspective, we would have to give priority to Amey's M4 & M48 closures, because they obtained roadspace from us long before we received the below email.

The 15th to 17th May are also unavailable, as we will be closing the M5 Jct 16 SB exit slip (part of your diversion route) to complete a SMART motorway scheme.

We're also closing the M5 Jct 17 to 14 from the 26th April to the 3rd June. [REDACTED], please could you let us know whether SWTRA's attached diversion route would still be possible, when you do this? Will the M5 Jct 16 NB entry slip and SB exit slip remain open?

We have other closures of the M5 POW bridge WB and M48 Severn Bridge EB, but I don't believe these conflict with your diversion.

I don't see an alternative other than SWTRA keeping their section of M48 open on the dates highlighted above (other than perhaps for the M5 Jct 14 to 17 dates, subject to [REDACTED] confirmation). This is the busiest part of our network, and so we would have needed significantly more notice to fit you in sorry.


I understand that you have programmed maintenance work starting on the Prince of Wales Bridge on 8th July 2024. I also understand that you will undertake the work under full closures and that you intend to use the 'old' Severn bridge and along the M48 as a diversion route

As you are aware, it was our intention to resurface the eastbound side of the M48, from M4 J23 to M48 J2 Thornwell. The carriageway will soon be in urgent need of attention.

It is our intention to start the resurfacing work on Monday 13th May for 5 weeks (approx.), while working under full night-time closures (8pm to 6am) with traffic being diverted over the Prince of Wales Bridge. 



Good afternoon 

Thanks for your email regarding SWTRA works with diversions onto the National Highways network.

Apologies for any confusion and please be assured that we do not intend for any of our works to proceed with an unauthorised diversion onto your network.

We are aware of the National Highways planned closures around the M48, M4 POW bridges and M5 over the Jan-March period, via one.network and our colleagues in the SWTRA network occupancy team.

The Welsh Government traffic order (attached for information) referenced in the SW Argus article is intended to enable upcoming works on two of our schemes, for M48 eastbound resurfacing (led by [REDACTED] copied) and M48 westbound sign and VRS installation. However, these will only require short-term closures over limited nights, and will certainly not run for the entire period January to March.

Tenders are still in progress and we do not yet have firm programme dates for our intended works; however, we have made our contractors aware of the NH planned closures dates and we are instructing that the programme must avoid clashes, including liaison with yourselves to confirm suitability of the diversions on proposed dates.

Please could you confirm that this email address and your contact details below will be the most appropriate point of contact to liaise on the specific details in due course?

In terms of the proposed diversion routes, given the locations of the SWTRA works on the M48 (between J2 and the M4 J23) and lack of alternatives within the South Wales network, we would request NH approval to use the diversions described in the attached "Made 2nd Public Notice" (page 2). Please could you advise of any further information you require on this? As above, once appointed, our contractors will be in contact regarding suitable dates.

We look forward to hearing from you. Apologies again for the confusion and we will seek to review for any improvements needed in our project communications with yourselves going forward to avoid a recurrence.

It states that there will be closures of the M48 from Jct 2 to the M4 every night from 15th Jan to 31st March, and that the proposed diversion is onto the National Highways network (M4 to Almondsbury interchange, M5 to Jct 16, turn and return).

Is this correct? I'm not aware that we've received any requests from SWTRA for a diversion onto our network?

I just want to clarify that we do not approve of this diversion onto our network. This is because we need to be formally approached to approve any diversion. And also, because we have part of the proposed diversion route closed on some nights.
