Yes happy to do this. I think [REDACTED] is thinking about the PoW waterproofing & surfacing scheme for the middle 1km cable stayed bridge. This work is planned for July – Oct this year and will involve a 5.5 km contraflow. We are working on a project to replace the central res barrier with a concrete one, across the whole bridge, but this is currently down for RIS3 - 25/26 and is still in the feasibility stage.

We are planning to set up an operations working group for the resurfacing project which I'm hoping will address many of these issues. We currently have commercial, project delivery and customer workstreams, that report up to the monthly Project Board. But I now want to split out the operations side from the customer group as this current group is currently focused on comms strategy and stakeholder liaison with the route managers. The Operations Group would cover liaison with your Traffic Officer On Road work and also TM, Recovery, ROC, Police and M&R functions and include our Welsh colleagues.

I'm happy to put sometime in ahead of the first meeting if that would be useful. I'm just trying to get this set up, probably with the first meeting in a couple of weeks' time.

I've copied in [REDACTED], as we're managing this project between us.
